This office accepts cash, credit, debit, HSA and FSA cards for payment of services rendered. Billing information is kept on file for future billing purposes.

Insured Clients: the copayment amount for counseling sessions covered by primary health insurance is charged to the card on file at the time services are rendered. Clients using other covered benefits, the provider billing paperwork is required the day of your scheduled appointment. If not received before the appointment time cost of the session will be your responsibility.

Uninsured Clients: uninsured individuals and/or those choosing not to use health insurance are responsible for paying the full fee in cash, credit or debit card payment at the time services are rendered unless other payment arrangements have been made.

Appointments and Cancellations: the Yellow Schedule calendar is located on Olufemi's website for convenience. Emailed confirmations and reminders are courtesy only; not confirming is **not** considered a cancellation. Please keep track of your scheduled appointments. You may cancel by visiting the website, text message, email or call the office 48 hours prior to your scheduled appointment. If not, a \$70.00 cancellation fee is charged to the card on file.

Late Arrivals: All appointment times begin on top of the hour. Fifteen minutes past the scheduled appointment time is considered a cancelled no-show appointment. A \$65.00 cancellation fee is charged to the card on file.

Forms and letters: completion of forms, letters and other documentation, e.g. disability, FMLA, animal support, trans support, short disability, etc. A \$140.00 fee is charged for all prepared documentation. Prepared documentation takes me away from seeing clients and weekend personal time.

Appointment times and fees: individual sessions \$145.00 per session- 50 to 55 minutes in length. Couple sessions \$165.00- 50 to 55 minutes in length. Family sessions (3 to 4 people) 70 minutes in length- \$185.00 per session. Couples and families who do not share the same health insurance are required to use their individual health insurance for copayment at the time services are rendered.

Health insurance EOBs: [explanation of benefits] arrive 10 to 15 days after the service claim has been submitted to insurance. You pay a percentage of the full fee called a copayment at the time services are rendered. Most insurance companies have deductibles an out-of-pocket expense paid by patients at the time services are rendered. EOB claim results determine copayment adjustments.

Administration fees: a \$5.00 or \$3.00 administrative fee is included in all copayment amounts for utilization of credit, debit, HSA and FSA card reader fees and clearinghouse claim submission fees.

This is a legally binding contract between patient and provider. As such, I authorize my mental health provider Olufemi Sharp to keep my signature on file and to automatically charge my credit, debit, HSA or FSA cards for counseling services rendered. Charges may include late, same day, no-show cancellations and completed documentation fees.
